GENERAL NOTES AND INCLUSIONS:

- a) Subcontractor is responsible for timely submittals, re-submittals, RFI's and other project management functions so as not to negatively affect the project schedule.
- b) Subcontractor will provide an on-site superintendent/manager dedicated to the project that will be responsible for daily coordination meetings, weekly Owner meetings, 5-week schedules and other project management.
- c) Actual premium cost of the bond required hereunder shall be reimbursed by Contractor up to a maximum of 3% of the total Sub-subcontract amount. Reimbursement to be made upon submission to Contractor of an original paid and/or original receipted invoice from the surety or agent for the bond premium.
- d) Subcontractor is responsible for having all employees badged and carrying insurance per the requirements of the Deer Valley Airport and J. Banicki Construction.
- e) Hauling will only be permitted at night between 09:00 PM and 06:00 AM 5 Nights a week.

SCOPE OF WORK:

- a) Excess debris/material can be dumped onsite at locations denoted by Contractor. Haul-off generated from removals, the Contractor must approve disposal location prior to transporting off-site.
- b) The unit costs developed above shall be inclusive of all hours worked, including overtime, night, and weekend work, and note special times of night work only
- c) Spalls, overcuts, and damage to existing/new concrete or asphalt, materials, and structures, caused by Subcontractor operation shall be repaired and/or fixed per project specifications at no additional cost to the Contractor or Owner.
- d) Subcontractor shall be responsible for the vacuuming/sweeping and cleanup of all construction mess caused by Subcontractor activities.
- e) Subcontractor is responsible for flashing amber beacons on all equipment and vehicles, including hauling trucks and delivery trucks, at all times during construction.
- f) Subcontractor is responsible for "Orange and White" checked airport flags on all equipment, including hauling and delivery trucks at all times during construction.
- g) All vehicles operating within the airfield boundary be identified with a painted or magnetic sign on each side of the vehicle bearing the name and logo of the company.
